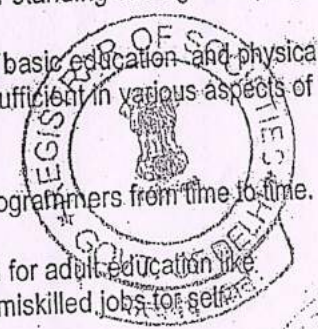

RULES AND REGULATIONS OF GYANWATI EDUCATIONAL SOCIETY

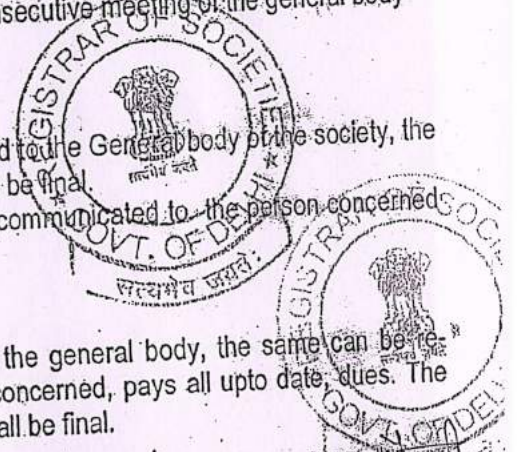
1. MEMBERSHIP

(b) Non payment of an subscription continuously for more than three months from due date.
(c) On his/her written resignation.
(d) He/She has not attended three consecutive meeting of the general body without any intimation.

4. APPELS:

The reason for rejection shall be communicated to the person concerned in writing.

5. RE-ADMISSION:
In case of member expelled by the general body, the same can be re-admitted provided the member concerned, pays all upto date, dues. The decision of the General Body shall be final.

"RULES AND REGULATIONS"

MEMBERSHIP

The membership of the society is open to any person or persons who has attained the age of majority and fulfils the terms and condition of the society with out discrimination of religion, cast, color or creed, but subject to the approval of the governing body, if the membership is refused to certain person or persons the reason for refusal shall be communicated to person concerned.



SUBSCRIPTIONS:-

Admission fee Rs. 50/- at the time of admission subscription Rs.20/-per month.

TERMINATION OF MEMBERSHIP:

The governing body shall have the power to expel from the society on the following terms and condition:

- a. On his/her death.
- b. Non payment of subscription continuously for more than three month from due date.
- c. On his/her written resignation.
- d. He/she has not attended three consecutive meeting of the general body without any intimation.

APPEALS

All the appeals should be preferred to the general body of society, the decision of the general body shall be final. Reason for rejection shall be communicated to the person concerned in writing.

RE-ADMISSION:-

In the case of member expelled by the general body, the same can be re-admitted provided the member concerned pays all up to dates dues. The decision of the general body shall be final.

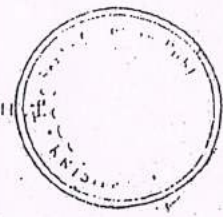

9) FUNCTION OF THE GENERAL BODY:

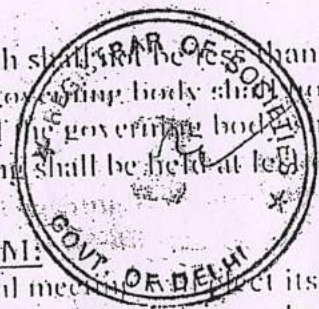
- All the members of the society will constitute the general body.

10. GOVERNING BODY:

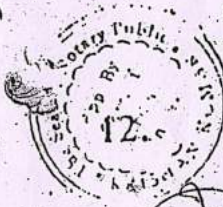

11. ELECTION AND QUORUM:

14. POWER AND DUTIES OF THE OFFICE BEARERS:

PRESIDENT

He will be the head of the society and president over the meeting of the general body and governing body. He will have the right of casting of vote in case of tie.

VICE-PRESIDENT

In the absence of the President, the vice-president shall enjoy all powers and duties which are ensocietyed to the President. He will also assist to the President in his work.

GENERAL SECRETARY:

- A. To sign on behalf of the society, conducts its correspondence and to records the proceedings of such meeting.
- B. To summon and attend the meeting of the general body.
- C. To call ordinary general meeting if desired on written request of at least twenty members.

SECRETARY:

In the absence of the secretary the secretary shall enjoy all powers & duties which are ensocietyed, to the general secretary. He will also assist to the general secretary in his work.

TREASURER:

He shall keep accounts of all receipts, and expenditure of the society and to furnish necessary information of the governing body. At the end of the after paying all expenses he will keep with

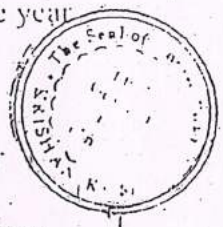

18. **AMENDMENT:**

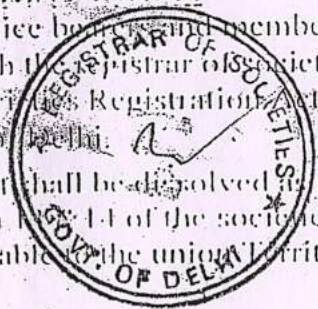

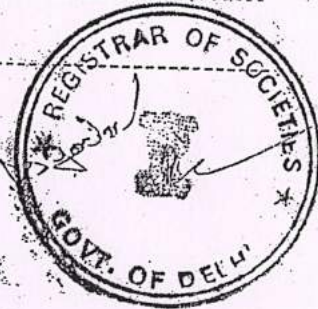

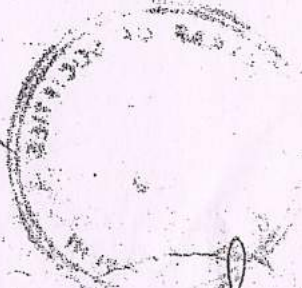
